The following clarifications and/or modifications shall be incorporated into plans and specifications for the above-referenced project and shall become part of the Contract Documents. All other provisions and requirements shall remain unchanged.

2	Section 01500	<p>Modification to Section 01500, Paragraph 2. FIELD OFFICE - Replace paragraph with the following text:</p> <p>A. General. <u>When deemed necessary as determined by the District's Project Engineer</u>, Contractor may place a field office and equipment at the project site as shown on the drawings during the entire time of construction beginning at the commencement date stated in the Notice to Proceed until the acceptance of the Project by the Agency. Upon execution or recordation of the Notice of Completion, or upon early release of the field office by the District, the Contractor shall remove the field office within 14 Days from said date or earlier if so specified in the Contract Documents, and shall restore the Site occupied by said field office to its original condition or better.</p>
