ADVERTISEMENT FOR BIDS

1. NOTICE. The ALAMEDA COUNTY FLOOD CONTROL and WATER CONSERVATION DISTRICT, acting by and through its ZONE 7 WATER AGENCY ("District") hereby gives notice that it will accept Bids for construction of the following public work:

DISTRICT PROJECT No. 308-24 REGIONAL GROUNDWATER FACILITIES IMPROVEMENT PROJECT PHASE I: TEST WELL CONSTRUCTION

2. BID SUBMISSION. District will receive sealed Bids no later than **10:00 a.m. on Thursday, August 29, 2024,** as determined by District staff by using www.time.gov. District's representative will call out the designated time in the District's office lobby at 100 North Canyons Parkway, Livermore, California, 94551, stating that the period for accepting Bids is closed. The Bid opening will be in accordance with procedures set forth in Document 00200 (Instructions to Bidders).

4. DESCRIPTION OF THE WORK. This project is a joint project between the District and the City of Pleasanton. The District is the sole contracting agency. The Work consists of, in general, drilling, constructing, developing, and testing up to three (3) test wells at up to three (3) different locations within the city of Pleasanton. The work includes but is not limited to, drilling up to three (3) 8-inch diameter exploratory borings to approximately 800 feet below ground surface at three different sites using a combination of casing-advance and mud rotary drilling methods, providing representative samples at a minimum of 5-foot intervals, preparing the holes for geophysical logging, reaming out a portion of the holes to 14-inch diameter, installing up to three (3) 8.625-inch minimum outside diameter (O.D) mild steel casing wells with specified screen intervals, developing the wells, and assisting with well testing at the direction of the District or the representative of the District.

Submittal of progress reports to the project manager on a monthly basis is required. Contractor shall report the actual footage of materials used including well riser casing, screen, filter pack, bentonite, 10.3 sack cement at the conclusion of each site.

Work also includes, but is not limited to:

- a. Contractor to contain all water and wastes generated as a result of the project and haul off site and dispose of in compliance with all laws and regulations including disposal at facilities that will accept the specific wastes. Contractor to provide all water, power, fencing, and sanitation facilities required to do the Work.
- b. Contractor shall furnish and install all new equipment as specified in the Contract Documents. Bidding Documents contain the full description of the Work. The Engineer's estimate for this Contract is approximately \$1,100,000.
- **5. CONTRACT TIME.** Work shall be finally completed within **180 Calendar Days** from the date when Contract Time commences to run. The contract time is anticipated to commence on or about October 7, 2024.
- **6. REQUIRED CONTRACTOR'S LICENSE(S).** Each bidder is required to have a current **California C-57 Well Drilling Contractor license** to bid this Contract. Joint ventures must secure a joint venture license prior to award of this Contract. Removal, handling, and/or disposal of hazardous materials may by law require hazardous substance removal certification by the Contractor's State License Board.
- **7. PUBLIC WORKS CONTRACTOR REGISTRATION.** A contractor or subcontractor shall not be qualified to bid on, be listed in a bid proposal, subject to the requirement of Section 4104 of the Public Contract Code, or engage in the performance of any contract for public work, as defined in this chapter [1770-1784 Labor Code], unless currently registered and qualified to perform public work pursuant to Section 7029.1 of the Business and Professional Code or by Section 10164 or 20103.5 of the Public Contract Code, provided the contractor is registered to perform public work pursuant to Section 1725.5 at the time the contract is awarded.
- **8. PREVAILING WAGE LAWS.** The successful Bidder must comply with all prevailing wage laws applicable to the Project, and related requirements contained in the Contract Documents. Pursuant to applicable provisions of the Labor Code, the District has implemented and shall enforce a Labor Compliance Program (LCP) for the Work. The successful Bidder shall be required to comply with all the requirements of the District's LCP and applicable provisions of the California Labor Code. In bidding on the Work, it shall be each Bidder's responsibility to evaluate the cost of complying with the District's LCP. Bidders shall include all costs of compliance with specified requirements in their bids.

- **9. MANDATORY PRE-BID SITE VISIT**. District will conduct a Mandatory Pre-Bid Site Visit at **9:00 a.m.** on **Thursday, August 15, 2024,** starting at 5997 Parkside Drive, Pleasanton, California, 94588 and then visiting each Project Sites. Any Bidder wishing to investigate subsurface conditions at the Site must schedule such a visit with the District in accordance with Document 00200 (Instructions to Bidders).
 - Requests for Information are due at **3:00 pm** on **Tuesday August 20, 2024**. The District will respond within 2 business days by addendum via their website and an email to the plan holder list.
- **10.SUBSTITUTION OF SECURITIES.** District will permit successful Bidder to substitute securities for retention monies withheld to ensure performance of Contract, as set forth in Document 00680 (Escrow Agreement for Security Deposits in Lieu of Retention), in accordance with California Public Contract Code, Section 22300. By this reference, Document 00680 (Escrow Agreement for Security Deposits in Lieu of Retention) is incorporated in full in this Document 00100.
- **11.PROCUREMENT OF BIDDING DOCUMENTS.** Bidding Documents are located online on the District's website at https://www.zone7water.com/construction-business-opportunities where Bidders may download copies for no fee. Bidders must complete the web form to download plans and specifications from the District's website to be put on the Planholders List. Addenda will be posted on the District's website. If a Bidder fails to be put on the Planholders List as required, the District reserves the right to reject the Bid as non-responsive.
- **12.BID PREPARATION COST.** Bidders are solely responsible for the cost of preparing their Bids.
- **13.RESERVATION OF RIGHTS.** District specifically reserves the right, in its sole discretion, to reject any or all Bids, or re-bid, or to waive inconsequential deviations from Bid requirements not involving time, price, or quality of the Work.
- **14.SUBMISSION OF CERTIFICATES OF REPORTED COMPLIANCE.** In accordance with the California Air Resources Board (CARB) and approved amendments to the In-Use Off-Road Diesel-Fueled Fleet Regulations. Contractor is required to submit certificates of reported compliance (CRC) at time of Bid Submission. Certificates must also be submitted for all subcontractors. All submitted CRCs must have a fleet identification number.
