1. NOTICE. The ALAMEDA COUNTY FLOOD CONTROL and WATER CONSERVATION DISTRICT, acting by and through its ZONE 7 WATER AGENCY ("District") hereby gives notice that it will accept Bids for construction of the following public work:

- 2. BID SUBMISSION. District will receive sealed Bids no later than 2:00pm on Tuesday, July 23, 2024, as determined by District staff by using www.time.gov. District will set up a Bid Box outside the front door at District's Main Office at 100 N. Canyons Parkway, Livermore, CA 94551. The Bid Box will be available to deposit bids starting at 12:30 pm on the day of the Bid Opening and will be removed promptly at 2:00pm. The Bid Box will be monitored by District staff. The Bid Opening will take place in-person and virtually via a Microsoft Teams webinar. The webinar link for the Bid Opening will be posted on District's website (www.zone7water.com) and may also be obtained by contacting the Project Engineer by phone or email. The district's representative will call out the designated time in the Zone 7 office lobby, stating that the period for accepting Bids is closed. Bids will be opened and read aloud for in-person attendees and for the virtual webinar. The Bid opening will be in accordance with procedures set forth in Document 00200 (Instructions to Bidders) and as modified in Document 00800 (Supplementary Conditions Division 0).

DESCRIPTION OF THE WORK. The Work consists of: repairing and grading eroded banks, installing rock slope protection including geogrid, installing willow stakes, and planting. Work shall be performed at one site along Line G-1-1 (Site 913) and two sites along Line B (Sites 914 and 915) in Pleasanton, California as

shown on the drawings. Site 913 is an approximately 120-foot long segment of eroded right bank of Line G-1-1, adjacent to a DSRSD wastewater treatment plant. Sites 914 and 915 are eroded banks that span approximately 155 and 140 feet, respectively, of Arroyo De Laguna. A staging area is available at each site, as shown on the plans.

The District anticipates that the majority of the Work will be performed during the hours defined in Section 01100 (Summary of Work). The engineer's estimate for this project is \$1,227,000.

- 4. CONTRACT TIME. A Notice to Proceed with Work is subject to receipt of all regulatory permits. Therefore, all heavy equipment in-channel work and implementation of erosion control may be performed during the two construction seasons of May 1, 2024 October 31, 2024 and May 1, 2025 October 31, 2025, or as directed by the Project Engineer. Work may not commence at any site unless all work can be completed within the same construction season. Final Completion of this Project shall be completed by December 16, 2025.
- 5. REQUIRED CONTRACTOR'S LICENSE(S). Final Completion of this Project shall be completed by December 16, 2024. Each bidder is required to have a valid and current California Class A General Engineering license to bid this Contract. Joint ventures must secure a joint venture license prior to award of this Contract. Removal, handling, and/or disposal of hazardous materials may by law require hazardous substance removal certification by the Contractor's State License Board.

PUBLIC WORKS CONTRACTOR REGISTRATION. A contractor or subcontractor shall not be qualified to bid on, be listed in a bid proposal, subject to the requirement of Section 4104 of the Public Contract Code, or engage in the performance of any contract for public work, as defined in this chapter [1770-1784 Labor Code], unless currently registered and qualified to perform public work pursuant to Section 7029.1 of the Business and Professional Code or by Section 10164 or 20103.5 of the Public Contract Code, provided the contractor is registered to perform public work pursuant to Section 1725.5 at the time the contract is awarded.

REQUIRED MINIMUM QUALIFICATIONS. A Contractor or subcontractor shall have the minimum qualifications to preform the work as described in Section 00450 (Statement of Qualifications for Construction Work).

6. PREVAILING WAGE LAWS. The successful Bidder must comply with all prevailing wage laws applicable to the Project, and related requirements contained in the Contract Documents. Pursuant to applicable provisions of the Labor Code, the District has implemented and shall enforce a Labor Compliance Program (LCP) for

the Work. The successful Bidder shall be required to comply with all the requirements of the District's LCP and applicable provisions of the California Labor Code. In bidding on the Work, it shall be each Bidder's responsibility to evaluate the cost of complying with the District's LCP. Bidders shall include all costs of compliance with specified requirements in their bids.

7. MANDATORY PRE-BID SITE VISIT. District will conduct a Mandatory Pre-Bid Site Visit at **10:00am on Tuesday, July 02, 2024** starting at 100 North Canyons Parkway, Livermore, CA 94551. Any Bidder wishing to investigate subsurface conditions at the Site must schedule such a visit with the District in accordance with Document 00200 (Instructions to Bidders). Attendance at the mandatory site visit will be taken. If a Bidder fails to attend the Mandatory Pre-Bid Site Visit as required, the District reserves the right to reject the Bid as non-responsive.

Requests for Information are due at **3:00pm on Friday, July 12, 2024**. The District will respond within 48 hours by addendum via their website and an email to plan holder list.

- **8. SUBSTITUTION OF SECURITIES** District will permit successful Bidder to substitute securities for retention monies withheld to ensure performance of Contract, as set forth in Document 00680 (Escrow Agreement for Security Deposits in Lieu of Retention), in accordance with California Public Contract Code, Section 22300. By this reference, Document 00680 (Escrow Agreement for Security Deposits in Lieu of Retention) is incorporated in full in this Document 00100.
- **9. PROCUREMENT OF BIDDING DOCUMENTS** Bidders may examine Bidding Documents at the District's offices. Bidding Documents are located online on the District's website at www.zone7water.com where Bidders may download copies for no fee. Bidders must complete the web form to download plans and specs directly from the Zone 7 website to be put on the Planholders' List. Any addenda will be posted on the District's website and may be sent by email to those on the Planholders' List. If a Bidder fails to be put on the Planholders' List as required, then District reserves the right to reject the Bid as non-responsive.
- **10.BID PREPARATION COST.** Bidders are solely responsible for the cost of preparing their Bids.
- **11.RESERVATION OF RIGHTS.** District specifically reserves the right, in its sole discretion, to reject any or all Bids, or re-bid, or to waive inconsequential deviations from Bid requirements not involving time, price, or quality of the Work.
