**SUBJECT:** PFAS Management Update

### **SUMMARY:**

- To support the Mission to deliver safe, reliable, efficient, and sustainable water, Zone 7
  Water Agency (Zone 7) manages Per- and polyfluoroalkyl substances (PFAS) detected in
  the Livermore Valley Groundwater basin. This action supports Strategic Plan Goal A –
  Reliable Water Supply and Infrastructure and Goal C Groundwater Management and is to
  implement Strategic Plan Initiative #1 Establish a diversified water supply plan, Initiative
  #2 Evaluate and develop appropriate new water supply and reliability opportunities,
  Initiative #7 Manage the GSA and implement the groundwater management plan, and
  Initiative #8 Study and refine knowledge of the groundwater basin.
- On August 31, 2022, staff presented the findings of the Desktop Contaminant Mobilization Study and recommended the PFAS Management Strategy to the Board. Since then, staff have implemented strategy components and completed various tasks over the last two years.
- As outlined in the strategy, staff have coordinated with the San Francisco Regional Water Quality Control Board (SFRWQCB) to assess potential sources of PFAS contamination. This ongoing effort is vital to the strategy to prevent active sources. In this workshop, the Executive Officer of SFRWQCB will inform the Board of the status of regulatory activities in the San Francisco Bay area and the Livermore Valley Groundwater Basin area.
- Following the SFRWQCB's update, staff will present the Board with a comprehensive review of the PFAS management strategy and an update on the progress.
